Terms & Conditions

- Independent Distributor of SAARVASRI HERBS is hereinafter referred as Distributor and SAARVASRI HERBS Pvt. Ltd. is hereinafter referred as SAARVASRI HERBS in this agreement of following Terms & Conditions.
- SHPL reserves the right to employ such measures as it deems necessary to determine and ensure compliance with its policies and procedures and make any amendments it deems necessary at any time to the Terms and Conditions, Pricing and/or Incentive. Terms and Conditions as amended in force for a particular period shall be applicable for arriving at any decision, in relation to the Distributor.
- Any individual who is of 18 years or above age and residing in India is eligible to become an Independent Distributor.
- The Distributor or its' employees (if any) shall not be franchisee / agent / employee of the Company in any sense. The Distributor is a separate independent entity associated purely on the present contractual terms and shall have no power or authority to incur any debts, contracts, obligations or liabilities or to make any representation or any warranties on behalf of SHPL.
- All Distributor' s are personally responsible for all statutory taxes and duties on earning from selling SHPL products. Distributor' s will receive the products, VAT paid wherever it is possible. However the Distributor is responsible to meet the local taxes as applicable, if required.
- It is expected that the Distributor would use his/her best efforts to promote the SHPL business and provide bona fide supervision and training of down line.
- The Distributor's initial appointment will be for a period of 12 months or 1 year from the Date of Joining or Distributorship. The Distributorship will be renewed automatically provided the Distributor has made or done minimum Personal Business Volume (PBV) of 1200 in the 1st year and 2400 per year from 2nd year.
- The Terms and Conditions shall constitute the conclusive contract between the parties.
- SHPL recognizes the sponsor as shown on the first original application completed, dated, signed by the applicant and entered in to SHPL's computer system.
- The Distributor shall handover all the money paid to him for the purchase of products / services or as advance by the Distributors and Distributors to the Company or authorised Galleries of the Company (as per the list published from time to time). SHPL shall not be responsible for any money that is not remitted at their respective authorised Galleries.
- The Distributor can display SHPL name, logo as designed by the Company for printing his/her personal stationary (with prior permission in writing). However the Distributor shall not use the trademark, patent or any other intellectual properties of SHPL for any other purpose other than for promotion of business of SHPL.
- Upon death of the Distributor, the rights and responsibilities of the Distributor are passed on to the rightful nominee as mentioned in the application form. The nominee shall be bound by the terms and conditions of the original Distributor agreement and abide by SHPL's rules and regulations, if he/she wants to continue with the Distributor.
- All payments should be made either by cash or demand draft payable at KOLKATA. Payment made is non-refundable and non-transferable.
- The Distributor indemnifies and holds SHPL harmless against all claims made by any third party, and any related damages and expenses (including reasonable attorneys' fees), arising out of or connected with the Distributor 's conduct, promises, the goods or services the Distributor offers, or any breach or violation of this agreement by the Distributor.
- The Distributor shall not make any offer or promises to any prospective Distributor or third party other than what is offered or promised by SHPL in its' official written communications. Distributor shall be solely responsible for all the breach of promise, damages and for the offers and promises made by him/her which are not authenticated by the SHPL.
- The Distributor understands that cross sponsoring and cross line jumping is prohibited in SHPL and may result in the imposition of penalty. As a last resort may be termination of this agreement, when there is no result after warning was given after such violation.
- The Distributor has to make minimum purchase every month as prescribed by the SHPL from time to time to become eligible for his/her incentive cheques.
- Distributors should sell the products according to the literatures and marketing materials provided by SHPL. Distributors are forbidde from making their own claims and preparing the selling materials by himself/herself without the prior written permission of SHPL.
- Company would deposit TDS against the income of the Distributor to the income tax department as required for the aggregate amount deducted for the financial year after the completion of respective financial year.
- The Company reserves the sole right to change, rectify and amend the structure, cancel and introduce rules and regulations; policies, and procedures, terms and condition from time to time and customer shall abide by the same.
- Any dispute arising out of or in relation to the terms and conditions shall be referred to a sole arbitrator to be appointed by SHPL, and the venue of such arbitration shall be at Barrackpore, Dist- 24 pgs (N), Kolkata-700120) . The Distributor shall not make any objection of whatsoever nature, if the arbitrator so appointed by SHPL is any way related to SHPL.
